Abstract

The David Reiner Papers consist of documents concerning the work of the Lexington Civil Rights Committee between the years of 1960-1972 and the Lexington/ Boston Fair Housing Federation from 1961-1965. David Reiner's "Lexington Civil Rights Committee Records, 1960-1972" chronicle the growth and demise of the 1960s Fair Housing Movement efforts to increase the number of African American families living in Lexington. The LCRC focus on housing was multidimensional, for it entailed working not only with home seekers (providing information about listings, subscriptions to the local newspaper, helping with home visits, testing for bias, supporting cases of discrimination) but within Lexington neighborhoods (brochures, informational coffee hours; good neighbor pledges), with Lexington realtors (attempting to win support for fair housing efforts, apprising of fair housing laws), with personnel managers in 128 businesses, and with other organizations outside of Lexington (e.g., Fair Housing Federation of Greater Boston, AFSC, and later MCAD, METCO, CORE, SNCC).

Funds were raised through membership fees (1965 membership 1016) and special events (lectures and concerts). Some funds supported activities in Lexington (LCRC newsletter and other publications, high school essay contests, summer camp for Roxbury and Lexington youth, support for black history books and curriculum); other funds went to activities outside Lexington and it was this proliferation of support for civil rights activities in Boston, in Mississippi, and elsewhere rather than Lexington-focused housing activities that contributed to the disbanding of the LCRC in 1972.

In addition to the LCRC records, David Reiner's papers include a folder on Hanscom AFB and Fair Housing in 1968 which reveals how ill-prepared the Air Force was to deal positively with fair housing for its African American personnel.

Biographical History

David Reiner (1928-2001) was an active member of the Lexington community. He and his wife Neva moved to Lexington in 1958 and he began a job as a technical staff member at MIT Lincoln Laboratory, working there until he retired in 1993. Reiner was active in local politics, serving on the Lexington Town Meeting for 15 years and was a member of the Democratic Town Committee for over 25 years, holding various offices including a four year tenure as chairman. He was also a member of the Lexington Civil Rights Committee (LCRC), fighting for social equality and working towards fair housing policies within the town. Reiner additionally participated as a member of the Lexington Interfaith Corporation and served as treasurer of the METCO Scholarship Fund of Lexington until his death in 2001.

Scope & Content

The *Lexington Civil Rights Committee, 1960-1972* series contains correspondence, meeting minutes, marketing materials, newspaper clippings, newsletters, budgets and various documents regarding the LCRC. These materials reflect the work that the Lexington Civil Rights Committee did with the Fair Housing Movement, striving to diversify the community and assist both African American families and realtors with housing.

The *Lexington/ Boston Fair Housing Federation, 1961-1965* series contains correspondence, meeting minutes, marketing materials, newspaper clippings, newsletters, and guidance about fair housing within Lexington and Boston.

The *Hanscom Air Force Base Fair Housing, 1968* series contains correspondence, brochures, reports, and meeting notes around issues of housing discrimination at Hanscom Air Force Base. Several documents report specific accounts of discrimination on the base, including first-hand accounts, and the review of those cases.

Organization & Arrangement

The folders are organized in the original order received, by organization and by year. Boxes I and II contain materials on the Lexington Civil Rights Committee, 1960-1972 ; and Box III contains materials from the Lexington/ Boston Fair Housing Federation, 1961-1965.and the Hanscom Air Force Base Fair Housing, 1967-1968. All materials have been digitized and are available through Digital Commonwealth.
